One of the wonderful characteristics of interpreting is that it is a practice profession. Just like doctors, counselors, and teachers, we perpetually improve and refine our craft. Discussion with other professionals who know and do the same work as oneself allows deeper reflection than one can accomplish alone. However, these kinds of conversations are often limited by time constraints, concerns about the maintenance of confidentiality, and other challenges.

TerpTerp Talks provide time and space for interpreters who work at UMD to engage in dialogue about both the technical and ethical aspects of our work in order to continually improve the interpreting services for the UMD community. These are not a series of workshops, but rather an opportunity to gather as a small group of people to have facilitated conversations to process the everyday issues that come up while we work.

Participation in the discussion sessions is free. However, because space is limited to 8 interpreters per session, a reservation deposit of \$20.00 will be collected to encourage commitment to attendance. Participants will be refunded the \$20 if they attend or if they cancel prior to 48 hours before the session. The deposits surrendered by late cancellations will

compensate the coordinator for the time spent managing a waiting list for other interpreters interested in participating.

CEUs:

Participants can fill out a PINRA and attach the event flier to request CEUs from RID prior to the first meeting. PCRID members may process these for free, and non-members may process them for \$25. Each session is expected to earn .2 CEUs, for a total of 1 CEU for participants who attend all five Fall sessions.

Learning Objectives:

Participants will be able to:

- 1. describe and discuss professional experiences with colleagues in a structured way that maintains confidentiality.
- 2. apply the Demand-Control Schema made popular in our field by Dean and Pollard to real-world circumstances.
- 3. reflect on their experiences, and those of their colleagues, effectively through application of a "What? So what? Now what?" (Witter-Merithew) model.
- 4. articulate reflective, well-rounded, evidence-grounded reasoning about their ethical decisions, rather than rule-based justifications.
- 5. incorporate insights gleaned from group reflective practice during supervision sessions into their regular professional decision making.
